- > The Renter is responsible for the conduct, dress and charges of their guests.
- The Renter is responsible for any damage caused during the agreed time period.
  It is recommended that the Renter inspect the property and document a list of existing conditions and submit it to the Saratoga Woods HOA Board before the rental date.
- > The Renter is responsible for ensuring that **NO GLASS CONTAINERS** are used in the pool and pool deck area.
- > The Renter is responsible for cleaning up after the event and disposing of all trash in available trash bins, located outside fenced area by clubhouse garage.
- Pool parties must be scheduled and paid for at least 2 weeks in advance.

The fees listed below are required at the time of the application. Please submit two checks, one for the pool rental per hour and a separate check for the refundable deposit. Checks must be made payable to Saratoga Woods HOA to initiate the agreement (no checks made to Mulloy Properties will be accepted). Deposit will be shredded if no damage found after inspection.

Please enclose both checks with Agreement and Wavier. Place in the <u>black mailbox next to the front door of the clubhouse</u> (not the mailbox on the street in front of the clubhouse). DO NOT MAIL.

- If you choose to bring a grill, the grill must be placed outside the fenced in pool deck area.
- NO GLASS CONTAINERS allowed in Pool or Deck area.

### **COVID-19 Agreement Waiver**

- 1. I understand the hazards of the novel coronavirus ("COVID-19") and am familiar with the Centers for Disease Control and Prevention ("CDC") guidelines regarding COVID-19. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the CDC and state guidelines are regularly modified and updated and I accept full responsibility for familiarizing myself with the most recent updates.
- 2. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to participate in Activities on the above described premises. While on the premises, I agree to strictly adhere to any restrictions contained on any posted signs or bulletins, and the following specific requirements in an attempt to avoid contact with COVID-19, or to prevent the spread of same, as follows:

A. TO ADHERE TO PROPER SOCIAL DISTANCING OF SIX (6) FEET FROM ANY OTHER INDIVIDUALS WHILE ON THE ABOVE DESCRIBED PREMISES.

I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being on the premises and participating in the Activities and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE (on behalf of myself and any minor children from whom I have the capacity contract) Saratoga Woods Community Association, Inc., its lot owners, officers, directors, agents, employees, pool and other Association management, insurers, attorneys and/or their assigns (the "RELEASEES") from any liability related to COVID-19 which might occur as a result from my being on the premises and participating in the Activities.
- 4. I shall indemnify, defend and hold harmless the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury.
- 5. It is my express intent that this Waiver and Hold Harmless Agreement shall bind any of my heirs, assigns and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES. This Agreement and the provisions contained herein shall be construed, interpreted and controlled according to the laws of the State of Kentucky. I HEREBY KNOWINGLY AND VOLUNTARILY WAIVE ANY RIGHT TO A JURY TRIAL OF ANY DISPUTE ARISING IN CONNECTION WITH THIS AGREEMENT. I ACKNOWLEDGE THAT THIS WAIVER WAS EXPRESSLY NEGOTIATED AND IS A MATERIAL INDUCEMENT THE PREMISSION GRANTED BY RELEASEES TO BE ON PREMISES AND PARTICIPATE IN THE ACTIVITES.
